5.1 Known Issues

- **SQLCORE-5608** Username validation is not case-sensitive.
- **SQLCORE-5609** A NullPointerException error might occur when accessing the About section from different products' main pages.
- **SQLCORE-5610** In the Overview tab, when a user Filters by Product, the filter text is still visible after refreshing or switching to another page and coming back, even though the filter is no longer applied.
- SQLCORE-5611 The user session does not expire.
- **SQLCORE-5612** In the Manage Tags tab, applied filters are not removed when deselected, though appearing deselected.
- **SQLCORE-5551** On SQLSafe, Backup and Restore operations from the Web Console are not working for both local and remote instances.

This section guides you through the installation of the IDERA Dashboard, a common technology framework for IDERA products.

Before you install the IDERA Dashboard, be sure to have:

- A local administrator account on the machine where you are installing the product.
- Microsoft .NET 4.0 Framework or later installed.
- The IDERA Dashboard Web Application service comes with SSL already set up. By default, SSL works with a self-signed certificate. This certificate can be used for encryption only and does not prove the identity of the server


That default certificate is not signed by any well-known Certification Authority (CA), and is intended only for use in testing purposes. When a user attempts to open the SSL version of the IDERA Dashboard Web interface, a warning appears in the browser window. For more information about running the IDERA Dashboard over SSL, see Run IDERA Dashboard over TLS or SSL.

9.1 Start your installation

You can install the IDERA Dashboard on any computer that meets or exceeds the product requirements.


To start installing the IDERA Dashboard:

1. Run IderaDashboardSetup in the root of the installation kit.




2. On the **Welcome to the IDERA Dashboard Setup** wizard, click **Next** to continue with the installation.


3. Review the license agreement. To accept this license agreement, click I accept the Terms and Conditions, and then click Next.



4. To Install the IDERA Dashboard on the server you are working in, select **Install the IDERA Dashboard locally**, and click **Next** to continue.



5. To install the IDERA Dashboard remotely, provide the **Dashboard URL**, **Dashboard Administrator Credentials**, the **Hostname**, and then click **Next** to continue.



9.2 Select an installation location

You can use the default install location or specify a different path (**Change**). For your first installation, we recommend using the default location. Click **Next** to continue with the installation.



9.3 Select a Windows user account to use for the service account

The IDERA Dashboard uses this account to connect, discover, and gather configuration information from SQL Servers in your Business environment. The installer grants the "Log on as a Service" right to the account that you specify.

To specify a service account:

1. On the **Service Account** window, type appropriate credentials in the provided fields under which the services run.


2. Click Next.



9.4 Select service ports to use for the IDERA Dashboard

The IDERA Dashboard uses ports **9291**, **9290**, **9292**, and **9294** for the web application and dashboard services respectively. However, you can specify different service ports.

To specify a service port:



1. On the Ports window, specify the ports you want the Web Application and Dashboard Services to use.

- 2. Verify that the Firewall allows TCP (Transmission Control Protocol) traffic through your specified ports.
- 3. Click Next.

9.5 Select a SQL Server instance to use for the IDERA Dashboard Repository database

The IDERA Dashboard is where all the Dashboard's configuration and aggregated data are stored.

To specify the SQL Server instance to install the Repository database on:

1. On the **Repository Database Setup** screen, specify the SQL Server instance you want to use for the IDERA Dashboard Repository database.


4. If you use **Microsoft SQL Server Authentication**, a new window displays where you can type the respective SQL Server login and password, Click **OK** to continue.

9.6 Complete the installation

Review the information on the **Ready to install the IDERA Dashboard** wizard and click **Install** to proceed.



Check the **Launch IDERA Dashboard** checkbox to run the application after the installation finishes. Click **Finish** to exit the IDERA Dashboard Setup Wizard.

10 Run IDERA Dashboard over TLS or SSL

The IDERA Dashboard Web Application service comes with TLS1.2 already set up. By default, TLS works with a selfsigned certificate. This certificate can be used for encryption only and does not prove the identity of the server.

That default certificate is not signed by any well-known Certification Authority (CA) and is intended only for use in testing purposes. When a user attempts to open the TLS version of the IDERA Dashboard Web interface, a warning appears in the browser window.

If you decide to continue working with this self-signed certificate, you must perform several steps to "accept" the certificate before you can access the site. This step usually occurs only the first time you access the site. Then the self-signed certificate is stored in the browser database marked as trusted. This scenario is suitable for testing purposes.

If you want to obtain a CA-signed certificate, use the steps below to obtain a certificate signed by a well-known CA. The role of a CA is to verify that the IDERA Dashboard Web Application you are trying to access actually has the name you are trying to access it by and that this server actually belongs to your organization.

10.1 Obtaining a CA-signed certificate

Certificates are issued by trusted third-party Certification Authorities (CAs). Many CAs simply verify the domain name and issue the certificate, whereas others (VeriSign, etc.) verify the existence of your business, the ownership of your domain name, and your authority to apply for the certificate, providing a higher standard of authentication.

Every browser comes with a pre-defined list of well-known CAs.

Along with the name of your organization and the name of your server, a CA-signed certificate contains the public key of the server. This public key is used by the browser to encrypt data sent to the server. There is a private key on the server. The server uses the private key to decrypt the data encrypted by the public key. The private key should be kept secure on the server to prevent unauthorized access.

keytool Options

- alias. All keystore entries are accessed via unique aliases. Aliases are case-insensitive. An alias is specified
 when you add an entity to the keystore using the -import command. Subsequent keytool commands
 must use this same alias to refer to the entity.
- **file**. Define absolute or relative path to your certificate file. If you define only the file name, it means, that the file is located in the root directory.
- **keystore**. Each keytool command has a —keystore option for specifying the name and location of the persistent keystore file for the keystore managed by keytool. 11 Upgrade Tomcat 7 manually

To manually update Tomcat 7.0 perform the steps below:

- 1. Open Windows Services Manager and stop Idera Dashboard Web Application Service.
- 2. Go to the official Apache Tomcat 7 downloads website (https://tomcat.apache.org/download-70.cgi), and download the zip files for **Core** and **Embedded** located under **Binary Distributions**.
- 3. Extract the Jar libraries of the **lib** folder from the **Core** zip folder.
- 4. Replace the Jar libraries in the installed IDERA Dashboard lib folder (i.e. "C:\Program Files\Idera\Dashboard\WebApplication\lib").
- 5. Extract the Jar libraries of the **embedded** zip folder.
- 6. Replace the Jar libraries in the installed IDERA Dashboard **lib** folder (i.e. "C:\Program Files\Idera\Dashboard\WebApplication\lib").
- 7. Open Windows Services Manager and start Idera Dashboard Web Application Service.

Steps to validate IDERA Dashboard Tomcat version:

- 1. Open Windows Command Prompt.
- 2. Type the DOS command to enter the IDERA Dashboard Web Application Lib folder (e.g. "cd C:\Program Files\Idera\Dashbaord\WebApplication\lib")
- 3. Type the following command: java -cp catalina.jar org.apache.catalina.util.ServerInfo
 - (i) To execute this command, you need to have Java installed and the JAVA HOME path set on the system. Click here for more information.
- 4. The output should be as shown below:

12 Migrate IDERA Dashboard Repositories

- Perform a restore operation of the .bak file in the SQL Server Windows instance.
- Once successfully restored the repository, go to the **CoreService** folder (i.e. "C:\Program Files\Idera\Dashboard\CoreService").
- Open IderaDashboardCoreServices.exe, change the value of the setting RepositoryHost for the SQL Server Windows Instance name, and save the changes.
- Start Idera Dashboard Core Services and Idera Dashboard Web Application Services.

2. 12.2 The source and destination instances are not connected to each other over the network

When connecting to the Linux SQL Server instance from Windows SQL Server Management Studio is not possible, you need to perform the backup of the IDERA Dashboard Repository on the Linux machine and restore it on the Windows machine. To achieve this, Microsoft provides sqlcmd command line tools. Find command line tools installation instructions here.

Find the commands to backup and restore databases using sqlcmd here.

Follow the steps below to perform the repository migration:

- Stop Idera Core Services and Idera Web Application Services on Windows Services Manager.
- · Log into the Linux machine.
- · Connect to the SQL Server Linux instance.
- Identify and backup the IDERA Dashboard Repository using the sqlcmd commands.

- · Copy the .bak file.
- Log in to SQL Server Windows instance machine and paste the .bak file to any desired directory.
- Open SQL Server Management Studio and connect to the Windows instance.
- Perform the restore operation of the .bak file as mentioned here.
- After the restore operation is complete, go to the **CoreService** folder (i.e. "*C:\Program Files\Idera\Dashboard\CoreService"*).
- Open IderaDashboardCoreServices.exe, change the value of the setting RepositoryHost for the SQL Server Windows instance name and save the changes.
- Start Idera Dashboard Core Services and Idera Dashboard Web Application Services.

To restore the IDERA Dashboard Repository on Linux, you can use SQL Server Management Studio to create a backup of the IDERA Dashboard Repository, then copy the .bak file to the Linux machine, and perform a restore operation using sqlcmd commands.



15 Advanced Filtering Grid


The advanced filtering allows you to apply multiple filters using conditional statements such as AND, OR, or NOT, and operators like Does not contain, Contains, Equals, Does not equal.

The principal function of this filtering option is the **Advanced Filter** button.

15.1 Advance Filter

When you select the Advanced Filter button, a drop-down menu opens with a list of configured filters.

At the top of the drop-down list, you have the option to **Create New Filter,** the button opens a new wizard:



On the **Custom Filter Name** define a name for the filter.

The **Add Filter** button adds a row of parameters to define the filter, according to the order, on each raw field you can select:

You can add as many rows as you require in your filter.

After configuring your filter you can **Apply Filters without Saving** and the filter will be available in the principal drop-down list with an **Unsaved Filter** name.

Or **Save and Filter** and the filter will be saved with the name you assigned to it. After saving a tag will be placed above the grid.

Pointing to the filter name, the **Edit** and **Delete** options will display. The **Save** option will only be available for Unsaved filters.

The **Edit** opens the advanced filtering wizard again, you can change parameters and Apply or Save your filter.

The **Delete** option deletes the filter permanently.





\Users\Administrator\keystore.ImportKey
```

- 13. Use Internet Explorer to download the intermediate certificate chain for the Certification Authority (CA). For example, point Internet Explorer to https://certificates.godaddy.com/repository/.
- 14. Save the intermediate certificate chain to the root directory of the disk C:\ on the server hosting the IDERA Dashboard services.
- 15. Import the received trusted certificate into your keystore file, by running the following command in your Command Promp window:

```
keytool -import -alias intermed -file c:\sf_issuing.crt -keystore c:
\Users\Administrator\keystore.ImportKey -trustcacerts
```

- (i) Internet Explorer may change the file extension. If the command above does not work, try sf_issuing.cer instead of sf_issuing.crt.
- 16. Open Windows File Explorer on the machine hosting the IDERA Dashboard services. Navigate to the following directory C:\Program Files\Idera\Dashboard\WebApplication\
- 17. Rename the file keystore to keystore.old.
- 18. Then rename the file C:\Users\<your username>\keystore.ImportKey to C:\Program
 Files\Idera\Dashboard\WebApplication\conf\keystore, and move that file into "C:
 \Program Files\Idera\Dashboard\WebApplication\conf".
- 19. Finally, restart the IDERA Dashboard Web Application service to complete the setup, and log into the IDERA Dashboard to verify that the certificate has been successfully applied.

keytool Options

- alias. All keystore entries are accessed via unique aliases. Aliases are case-insensitive. An alias is specified
 when you add an entity to the keystore using the -import command. Subsequent keytool commands
 must use this same alias to refer to the entity.
- **file**. Define absolute or relative path to your certificate file. If you define only the file name, it means, that the file is located in the root directory.
- **keystore**. Each keytool command has a —keystore option for specifying the name and location of the persistent keystore file for the keystore managed by keytool. A keystore is created when you use —import command to add data to a keystore that does not already exist. If you do not specify a —keystore option, the default keystore is a file named .keystore in your home directory (as determined by the "user.home" system property). If that file does not already exist, it will be created.
